## 永續發展與大學社會責任推動委員會設置要點

### Directives for the Establishment of the Sustainable Development and University Social Responsibility Committee

Amended on September 4, 2019 by the Academic and Executive Council

Amended on May 8, 2024 by the Academic and Executive Council

Amended on March 25, 2026 by the Academic and Executive Council

Article 1. National Taiwan Normal University (hereinafter referred to as “the University”) hereby establishes the Sustainable Development and University Social Responsibility Committee (hereinafter referred to as “the Committee”) in accordance with UN SDGs to set sustainable development as the overall goal of education; implement it in teaching and research, social responsibility, international connections, and school management as a diverse, inclusive, and sustainable campus transformed into a national education and research institution that promotes sustainable development.

Article 2. Duties and responsibilities of the Committee are as follows:

1. To support SDGs, promote and build a welcoming, diverse, inclusive, and circular campus environment and development policies.
2. To encourage research related to sustainable development and remain abreast of the latest international trends.
3. To promote social responsibility and international sustainable development initiatives.
4. To promote relevant education and to build up staff and students' sustainable development literacy.
5. To strengthen the relationship between the University, the community, and society, and build regional partnerships.
6. To organize a platform for sustainable university development and sustainable industry strategies.
7. Integrate campus environmental safety and health, disaster prevention and response, energy management, and sustainable governance to enhance campus resilience and sustainability performance.

Article 3. The Committee shall consist of 11 to 13 members. The composition of the Committee shall be as follows:

1. The president shall serve as chair.
2. The executive secretary shall assignee by the Chief Commissioner.
3. The ex-officio members shall be six persons, namely, the Vice-President, the Provost, the Dean of Academic Affairs, the Dean of the Faculty, the Dean of General Affairs, the Director of Research and Development, the Director of International Affairs, and one student representative.
4. 3-5 internal or external scholars and experts shall be selected by the president to serve on the Committee.

Article 4. The Committee shall be mission-oriented with members serving a 2-year term without compensation. Committee members may be elected to a second term. For mid-term vacancies, another member may replace the absentee till the end of the original term.

Article 5. The chair shall oversee affairs, whereas the executive secretary shall speak on behalf of the Committee.

Article 6. The Committee may set up relevant working groups as necessary.

Article 7. The Committee chair shall convene at least once a year. When necessary or at the request of over 5 members, the convener may hold interim meetings.

Article 8. The Directives and any amendments there to shall be implemented upon passage by the Academic and Executive Council.
